If the closing of Interstate 70 occurs, the race will be postponed a week to March 3rd. Due to print times, one must pre-register by Feb. 14th to guarantee a shirt. Completed registration after the 14th will be accepted up to race time. Shirts will be provided to these participants while supplies last.
